#### **SUBSTRATE QUALITY / PRE-TREATMENT**

Casco® LimTvätt is not suitable for sensitive surfaces such as those painted with alkyd or oil paints, untreated wood, etc.

We recommend performing a preliminary test.

#### **MIXING**

Casco<sup>®</sup> LimTvätt can be mixed with water to loosen adhesive residues. Mix 1–2 parts Casco<sup>®</sup> LimTvätt with 10 parts water.

#### **APPLICATION**

Casco® LimTvätt is intended for removing adhesive residue and stains that have dried. When removing these, use Casco® LimTvätt in concentrated form.

Apply Casco® LimTvätt. Leave to work for a few minutes. Rub with a cloth or, in tougher cases, a scouring pad. Wipe up the dissolved adhesive residue. Clean with water and wipe down with a clean cloth.

It may sometimes be necessary to leave Casco® LimTvätt to work for 10–15 minutes.

NB! If the product is left to work for too long, it may damage the surface of delicate materials.
