DIRECTIONS FOR USE

Pull off lid and open closure. Find start wipe in centre of roll. Pull out approx. 30cm of wipes and thread through lid.

Replace lid immediately and reseal closure.

For more heavily soiled surfaces or hardened SMP products, let the napkin process the stain a short while before cleaning.

Could cause allergic reaction.

After use wash hands with soap and water.
