# **APPLICATION INSTRUCTIONS**

#### SUBSTRATE PREPARATION

Joint interface must be clean, dry and free from oils, loose aggregates, laitance, release agents, waterproofing and other contaminants. Surfaces must not be impregnated.

#### **DIRECTIONS FOR USE**

For patching is contact gluing the best way; apply the glue on both surfaces and wait until the glue is dried. This normally takes 30 minutes. Press surfaced together with the highest possible pressure. The glue will fix immediately. The fitting must be done with precision as no adjustment is possible after bonding.

For montage gluing (collage); apply the glue on one surface, press together at once or wait maximum for 5 minutes.

Preferably not to be used on thin textiles as the glue may penetrate and cause staining. Clean glue spots immediately with water.

Joint interface must be clean, dry and free from oils, loose aggregates, laitance, release agents, waterproofing and other contaminants.

Surfaces must not be impregnated.

#### **APPLICATION METHOD / TOOLS**

Trowel or brush

#### **CLEANING OF EQUIPMENT**

When working with adhesive, cleanliness must be observed. Therefore always work carefully and systematically in order to avoid unnecessary spillage.

To remove glue from skin use soap and water before the glue has dried.

Equipment, tools are removed with water if the glue is un-dried.

Cured adhesive can with some effort be removed with Casco Limtvätt or white spirit or has to be removed mechanically.

On skin, uncured adhesive is wiped off with a rag, then wash with soap and water.
