APPLICATION INSTRUCTIONS

SUBSTRATE QUALITY

ZM RAPID is suitable on substrates like:

- Concrete
- Cement and rapid cement screeds

SUBSTRATE PREPARATION

REQUIREMENTS OF SUBSTRATE

- Adequate strength, bearing strength, dimensional stability and permanent dry.
- Free of layers which reduce adhesion, e.g. dust, dirt, oil, fat, wax cleaning agents and loose particles.
- Separation layers, sinter layers, and other similar contamination should be removed through sanding, brushing, abrasive blast cleaning, milling or thorough cleaning.
- Old, loose and weak levelling layers should be removed mechanically.
- When installing floor coverings, the RH of the construction must not exceed 85%.
- Layers of water-soluble adhesives, e.g. sulphite adhesives, should be removed completely.
- Old water-resistant adhesives should be mechanically removed as thoroughly as possible.
- Old floors, such as ceramic tiles are to be thoroughly cleaned and sanded.
- OSB to be grinded intensively.
- Rooms that do not have a cellar underneath must to be sealed against rising dampness in compliance with the standard.
- The requirements specified in relevant valid standards, guidelines and specifications must be fulfilled.

MIXING

25 kg of ZM RAPID / 5,75-6,0 liter of cold water

APPLICATION

ZM RAPID is suitable for:

- For full-surface smoothing and leveling of the sub floors
- In residential, commercial, schools, office and hospitals
- Under textile, ceramic and elastic coverings
- For full-surface levelling under parquet (layer thickness must be at least 3 mm)
- For indoor use only.
- The leveling compound must be covered, preferably within 3 days, to prevent cracks.

PRIMING

For priming the substrates, use suitable Casco Floor Expert primer. For further information see technical data sheet of the primer.

RECOMMENDED METHOD OF WORKING

- Use a clean bucket.
- Pour ZM RAPID into cold, clean water and stir to a homogenous mixture (speed mixer recommended, 600 rpm, 3 min)
- Then pour out the levelling compound and spread using a toothed trowel. It is possible to achieve an even surface without difficulties. It is usually not necessary to remove trowelling defects or to level more than once.
- In case of thick layers, protect vertical elements with isolating strip.
- If a second layer of levelling compound is to be applied, the first levelling compound layer should be primed with VD (1:1) or VD FIX, when dry. The combined layer thickness, must not exceed the given maximum layer of the leveling compound. The second layer may not exceed the layer thickness of the first.
- Carry out preparatory work such as filling joints, evening out hollows and unevenness using the sturdy repair mortar EF.
- Water-bearing pipes in metal must be sealed to avoid contact with the leveling compound, since for example galvanized steel pipes don't have sufficient corrosion protection.
- Protect curing ZM RAPID from high ambient temper-
