APPLICATION INFORMATION

Consumption	0,3 liter to approx. 50 meter joint.
Ambient Air Temperature	Between +18 °C and +25 °C
Relative Air Humidity	20–70 % RH.
Curing Time	Within 24 hours the adhesive has created a transparent sealing.

APPLICATION INSTRUCTIONS

Cut of the tip of the bottle. Apply a thick string of adhesive to fill out unevenness. Within 24 hours the adhesive has created a transparent sealing of the edge between the folded floor covering and the wall.

SUBSTRATE PREPARATION

Before applying the adhesive make sure that the surface is clean and dust free.

CLEANING OF EQUIPMENT

Clean application tools with water before the adhesive has dried. Dried adhesive is dissolved in ethanol.
